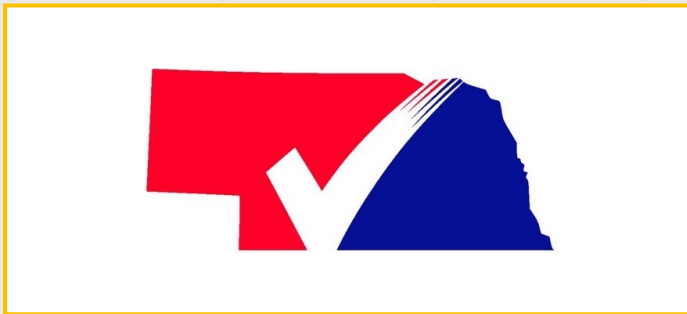

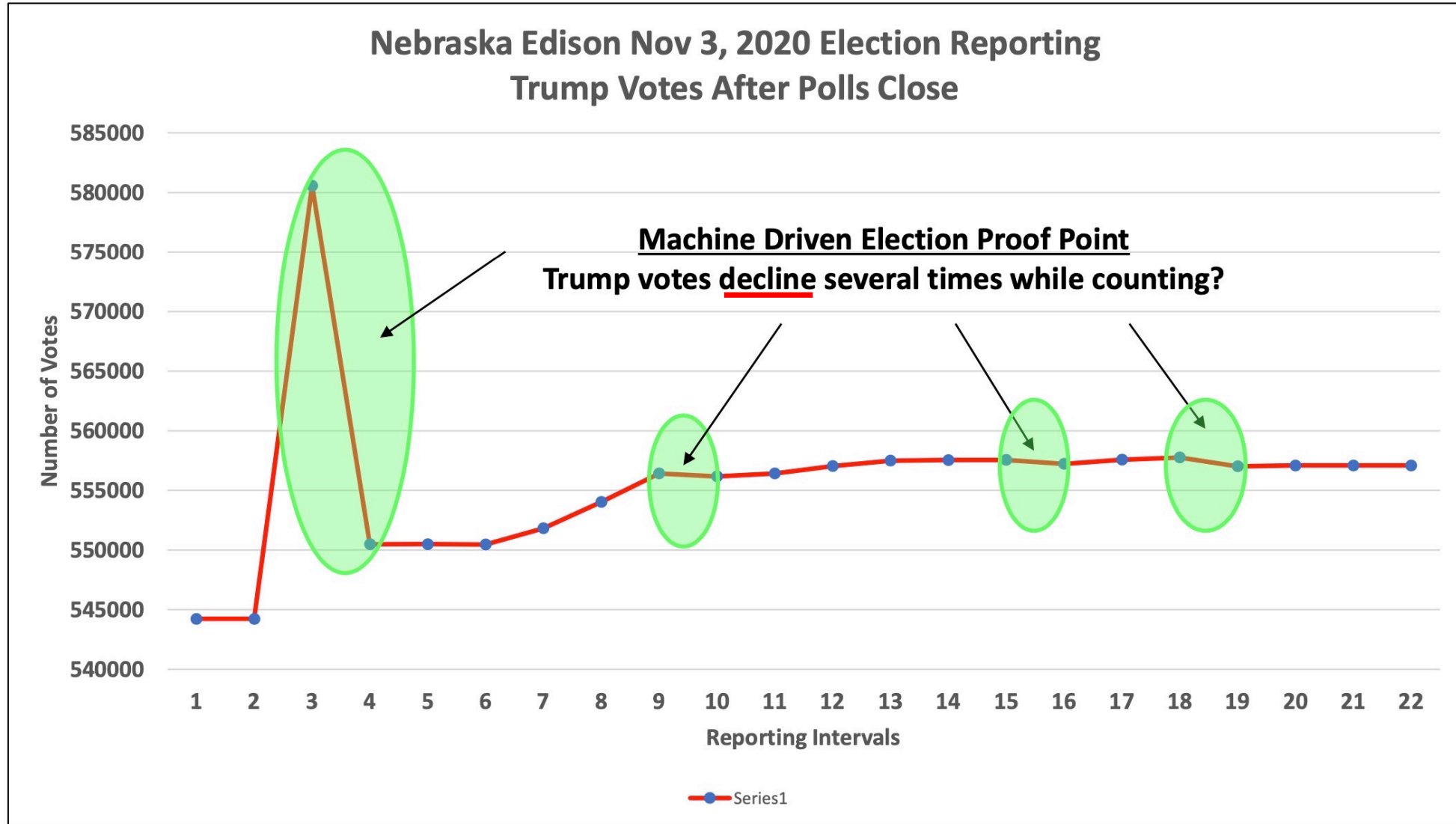

How Do They Process Votes?

We fill out a ballot and hand it to a Nebraska Election Official, in person or by mail, they enter it into a Scanner (97% of all votes) and **ES&S voting systems and software does the rest.**

One of the **big tools to prevent fraud is Segregation of Duties (SOD)**. For example, you can't have 1 person create an invoice, write the check to pay the invoice, balance the check book and provide the accounting reports without huge risk. The responsible party can simply write checks to themselves and report them as business expenses with any reason. ***Our Nebraska ES&S voting system violates every aspect of the concept.***

Did you Know?

What a wireless modem looks like if you looked inside of a computer? In Arizona, they found that they were inside their voting computers, breaking the contract. **Did you also know that in Nebraska we don't check the ES&S Systems?**

What vote changing software code looks like is impossible unless you're a software engineer. What is really shocking is that contractually, our Secretary of State, Robert Evnen, and his technical team **are not contractually allowed by ES&S to review the hardware or software of our election counting machines and report any Negative results.**



Did you Know?

That **our SoS says our ES&S voting doesn't have an internet connection, but the votes in every county were reported in near real time** to the state?

That **hackers have proven** that with brief access to the memory card that transfers votes between the counting machines not connected to the internet and the connected machines, **they can easily manipulate elections** by changing the votes on the memory cards as they move from the computers not connected to the internet?



Did you Know?

That **by bringing back moved and dead voters to the registration rolls, stored by ES&S and then mailing in votes for them** and then re-counting the “stuffed” ballots will always show our voting machines are right?

In Nebraska, **58,000+ voters were added to registrations in 2020 before the election and then 26,000+ registered voters were removed by ES&S between Feb & March 2021 after the election.** *Who were these people?*

There was an increase of **55,629 people who voted** in 2020, when the **increase to the eligible voter population was only 41,850.**

The **ES&S** invoices **charged Lancaster County for 246,929 ballots. Lancaster County Election Commissioner Shively's Official Final Results says 158,801 ballots were cast.** **Why were 88,128 - 55% - extra ballots ordered?**

When we asked, **County Election Officials** have written us saying they **don't have or keep the election ballot images from 2020**, THIS IS **NOT in accordance** with Nebraska Election Law. **WE GUESS ES&S has the records.**

This MEMORANDUM OF AGREEMENT ("Agreement") by and between the Center for Internet Security, Inc. ("CIS"), operating in its capacity as the Multi-State Information Sharing and Analysis Center (MS-ISAC) and the Elections Infrastructure Information Sharing and Analysis Center (EI-ISAC), located at 31 Tech Valley Drive, East Greenbush, NY 12061-4134, and Lancaster County, Nebraska (Entity) with its principal place of business at: 555 S. 10th St., Lincoln, Nebraska 68508, for EDR Services, as defined herein below (CIS and Entity collectively referred to as the "Parties").

V. Title

The EDR Services include use of software that is licensed to CIS by a third party provider, CrowdStrike, Inc. ("CrowdStrike"). All title and ownership rights of the software shall remain with CrowdStrike.

I am pleased to inform you that based on and in reliance upon the information and materials provided by Lancaster County, and the special circumstances Lancaster County faces administering elections in 2020, the Center for Tech and Civic Life ("CTCL"), a nonprofit organization tax-exempt under Internal Revenue Code ("IRC") section 501(c)(3), has decided to award a grant to support the work of Lancaster County ("Grantee").

The following is a description of the grant:

AMOUNT OF GRANT: \$404,584.50 USD

That **Lancaster County accepted \$400,000 of "Zuckerbucks" from Mark Zuckerberg of Facebook**, to "help" in getting the vote in and counting the votes.

*That in **Lancaster County**, we **spent \$13,000+ of Zuckerbucks** on voter Education and \$266,000+ on mail-in voter supplies and \$10,000+ for drop boxes. **I wonder what the voter education was like? 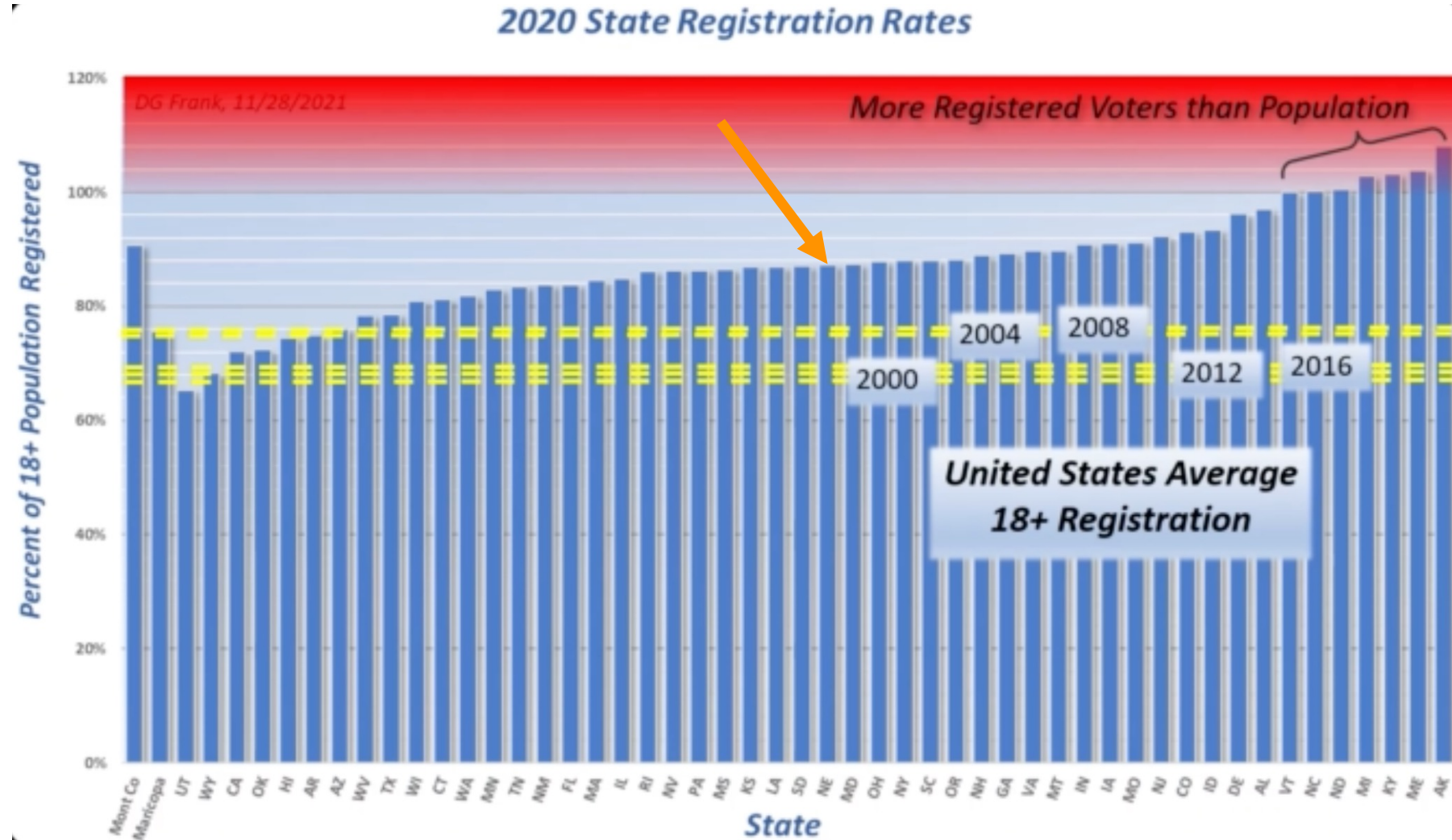

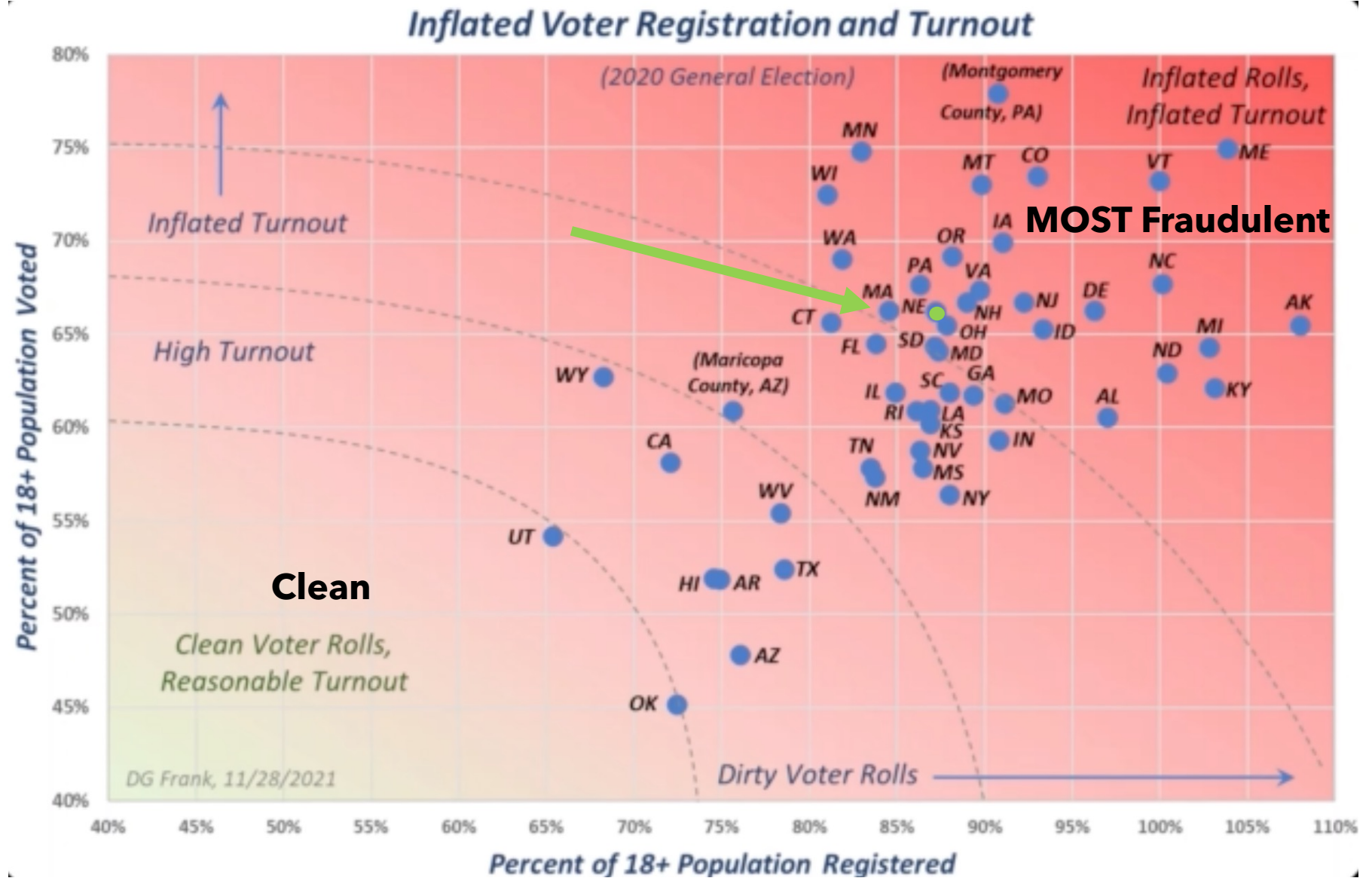

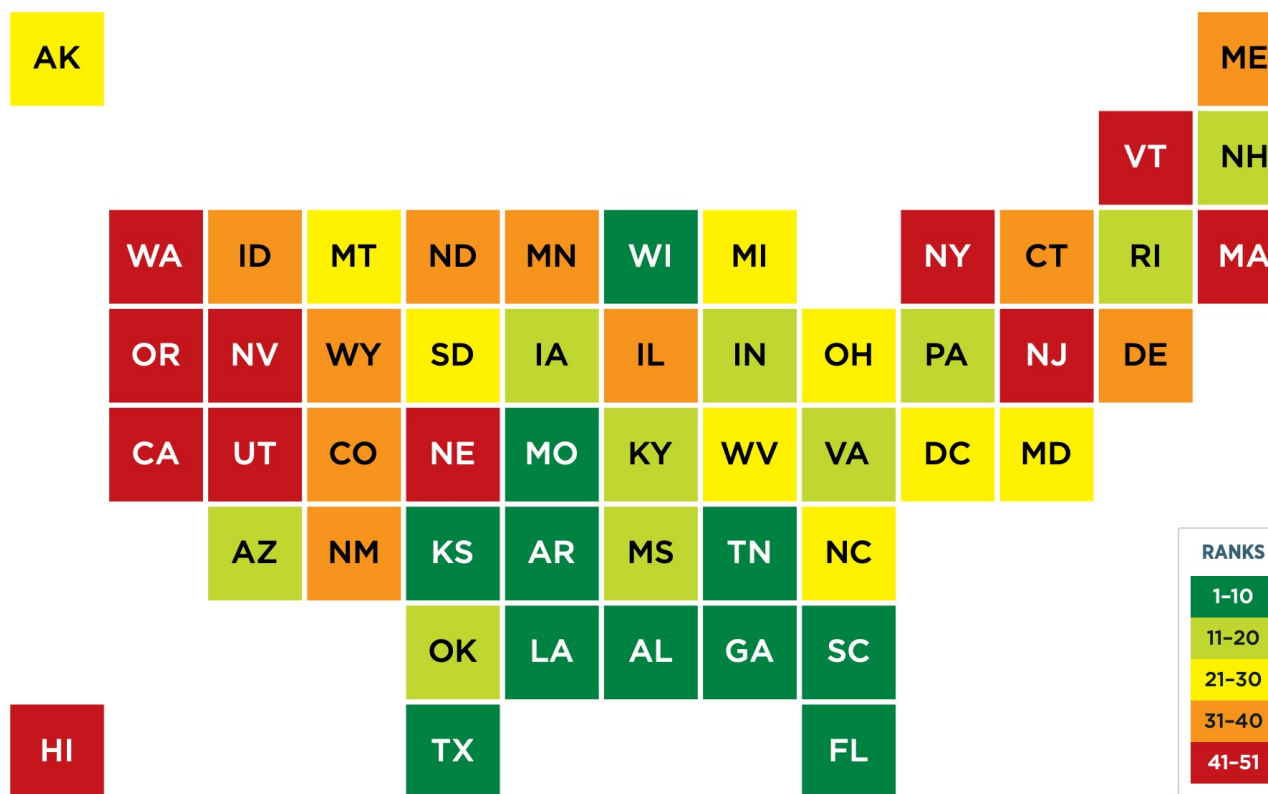

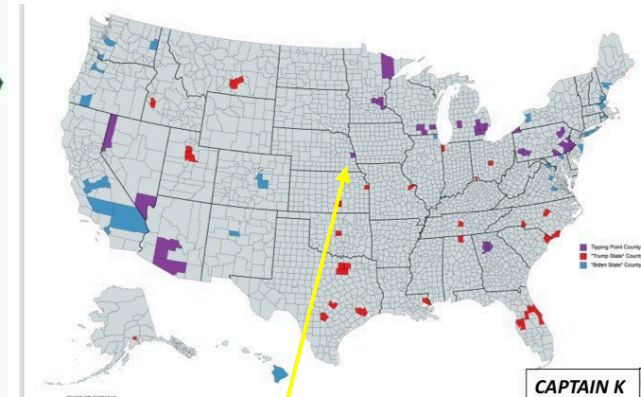

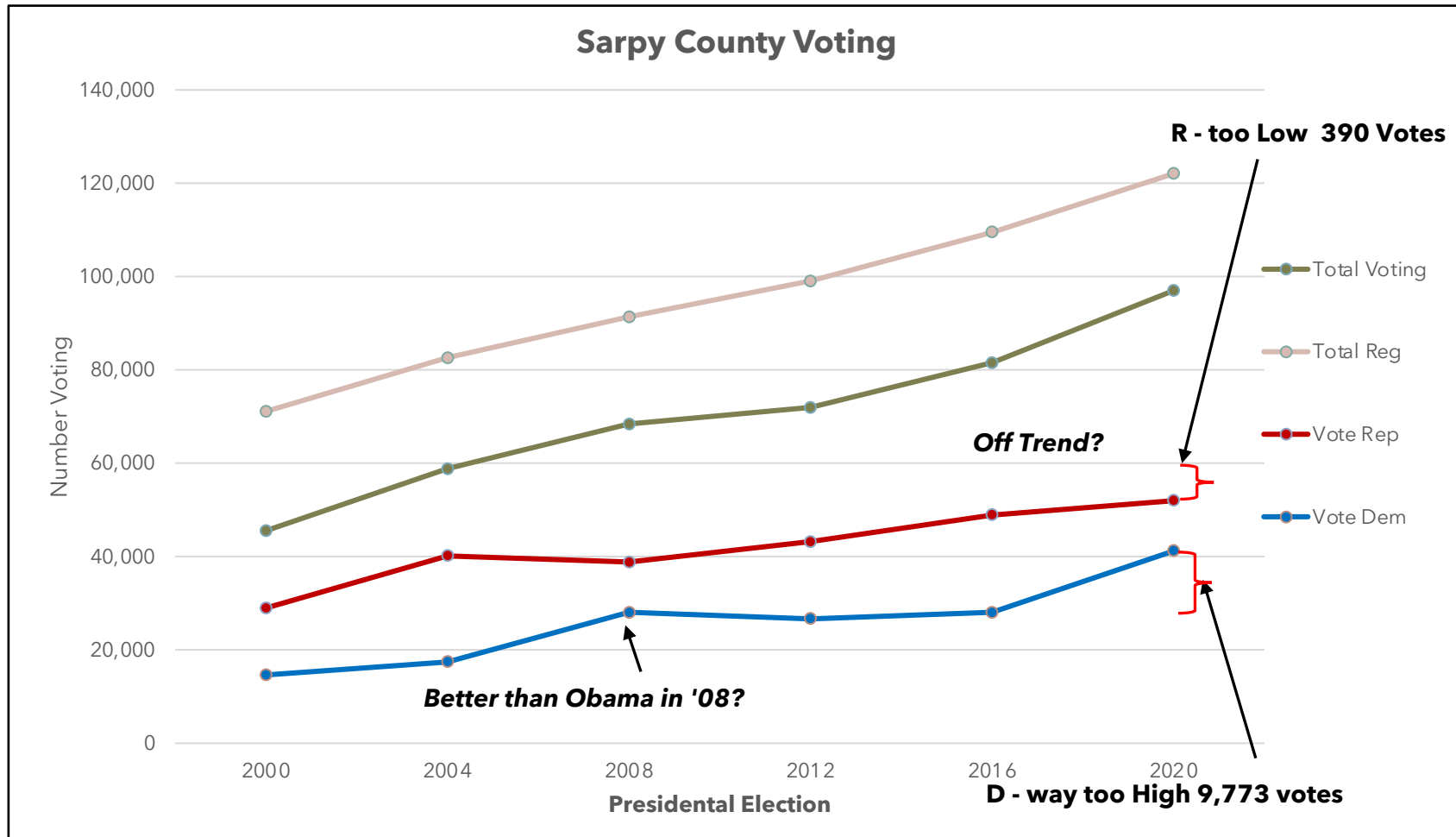
Red State Trump Trend - Registrations and Votes UP!

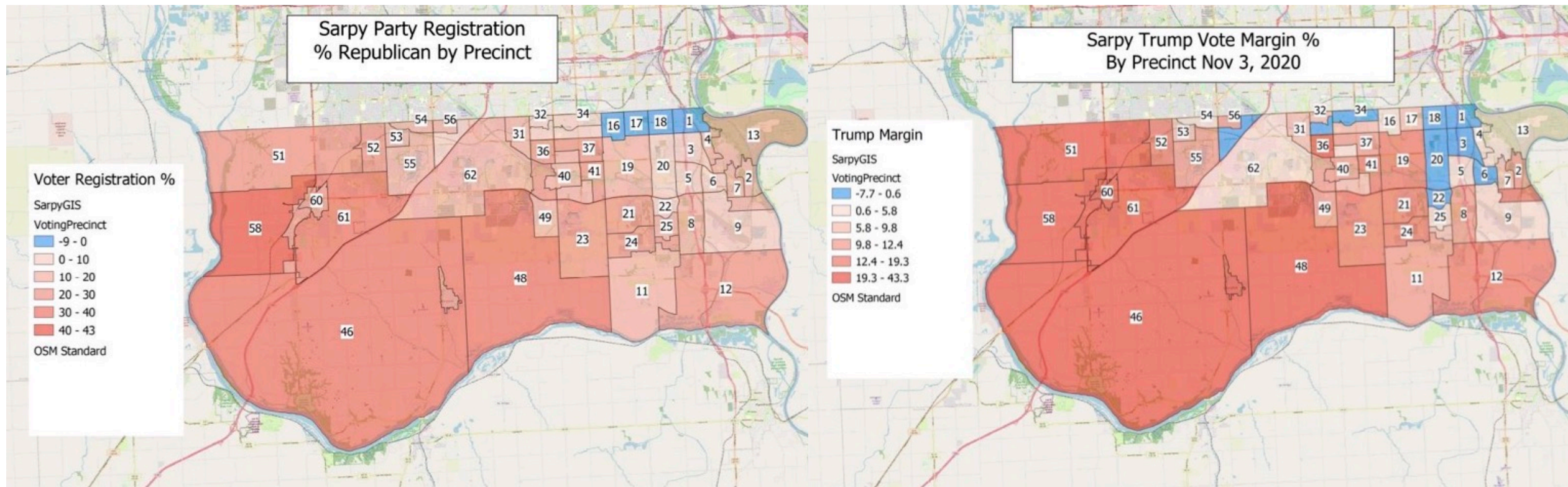
Poor People Get their Votes Stolen FIRST – Arizona Report



Sarpy County Poorest Neighborhoods in Bellevue



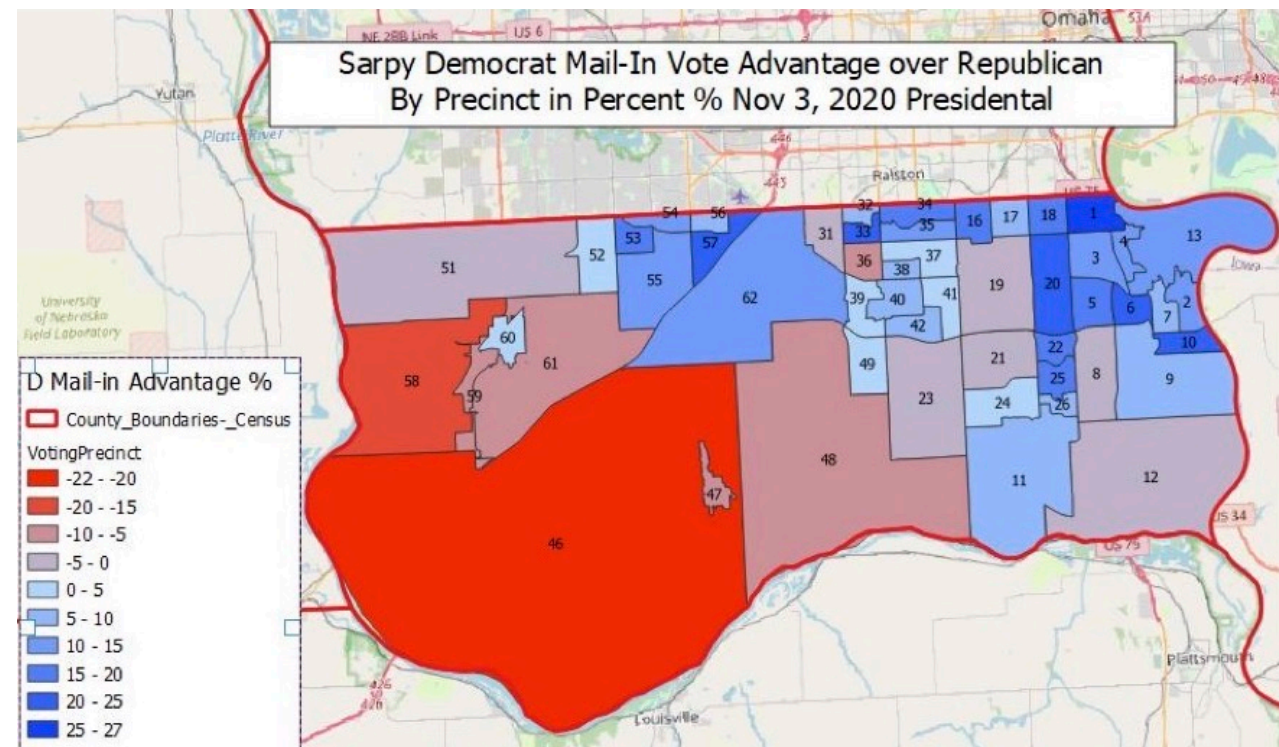
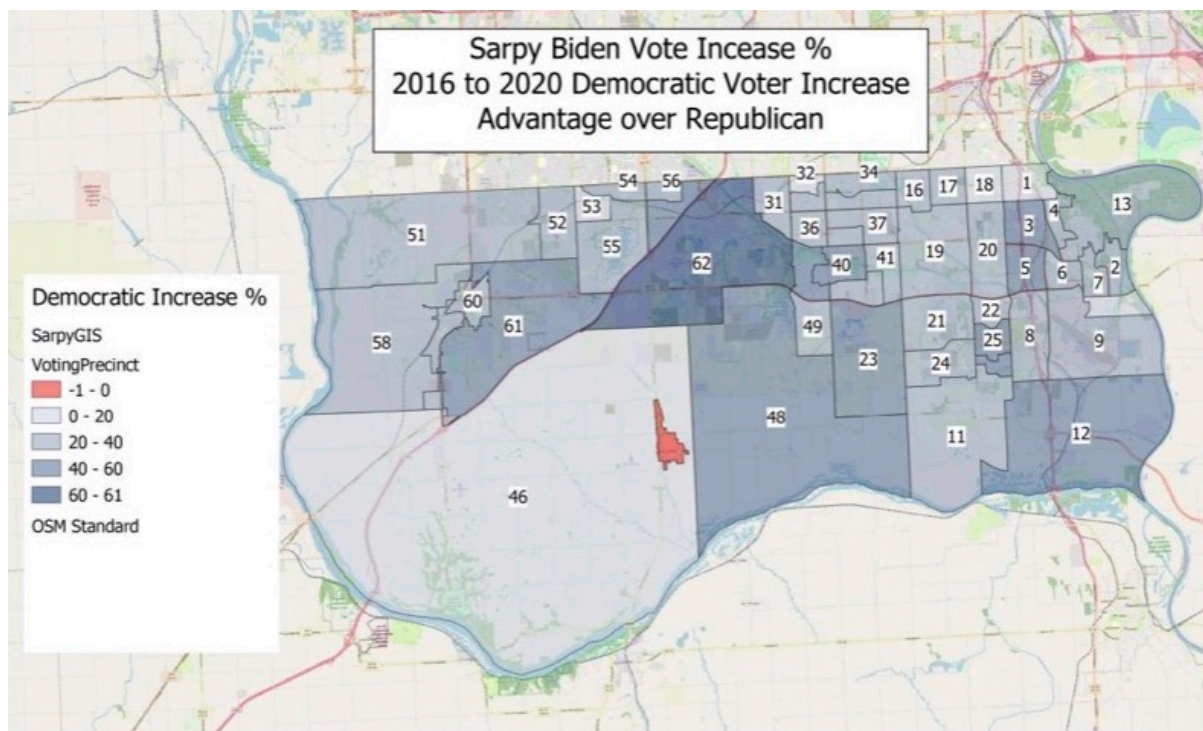

Excess Votes and Fraudulent Results

In Sarpy County, of the nearly **25,000 votes** cast, **Jen Day defeated incumbent Andrew LaGrone** by only **266 votes** for the District 49 Legislator seat.

Out of over **18,000 votes** cast, incumbent **Carol Blood defeated Rich Holdcroft** by only **160 votes** for the District 3 Legislator seat.

Both losses resulted in the Conservative candidate losing.

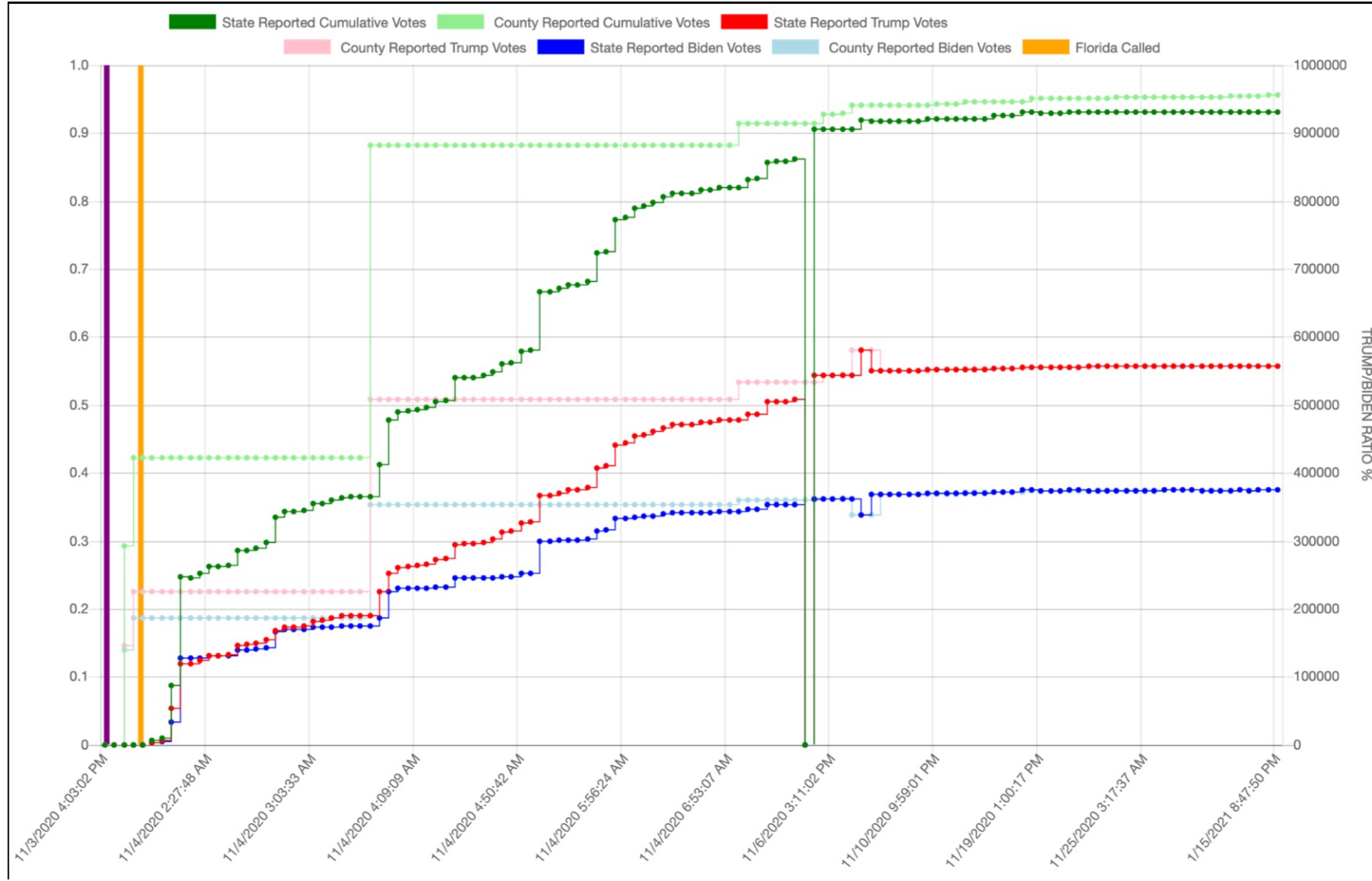
We estimate that in ***Solid Red Sarpy County*** we ***had over 8,000 "excess" votes.***

With limited canvassing, **we have dozens of affidavits** of unsolicited mailed ballots to people to wrong addresses, wrong people and people who did not request them.

How Our Elections Are Being Stolen, In a Nutshell

- 1) Artificially inflate the voter rolls;
- 2) Track the voters and tallies in real time;
- 3) Stuff ballots to achieve the pre-determined outcome;
- 4) Clean up the evidence after the fact.

The entire process is controlled, aided, and monitored by computer algorithms. They've been developing these algorithms for years, and they are quite efficient. They also have the infrastructure and the resources to implement it.

If Trump wasn't so popular, they wouldn't have had to push the algorithms so hard and the cheat would have been more difficult to glean from the real votes. But in 2020 it took everything they had, and it still didn't work.

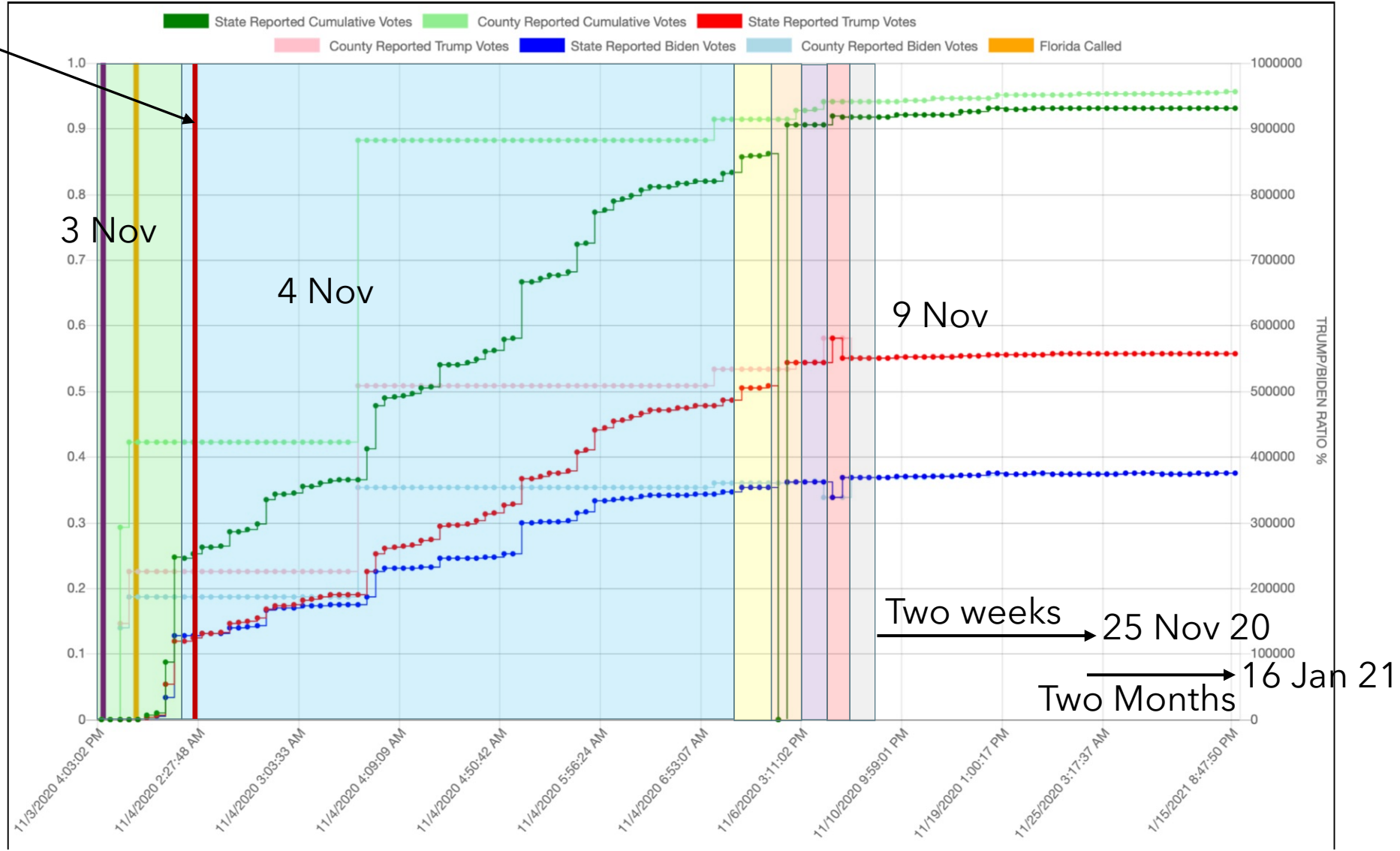
So they stopped the election, reset it, then resumed.

NEBRASKA - Comparison of County Reporting to State Reporting - 2020 Election

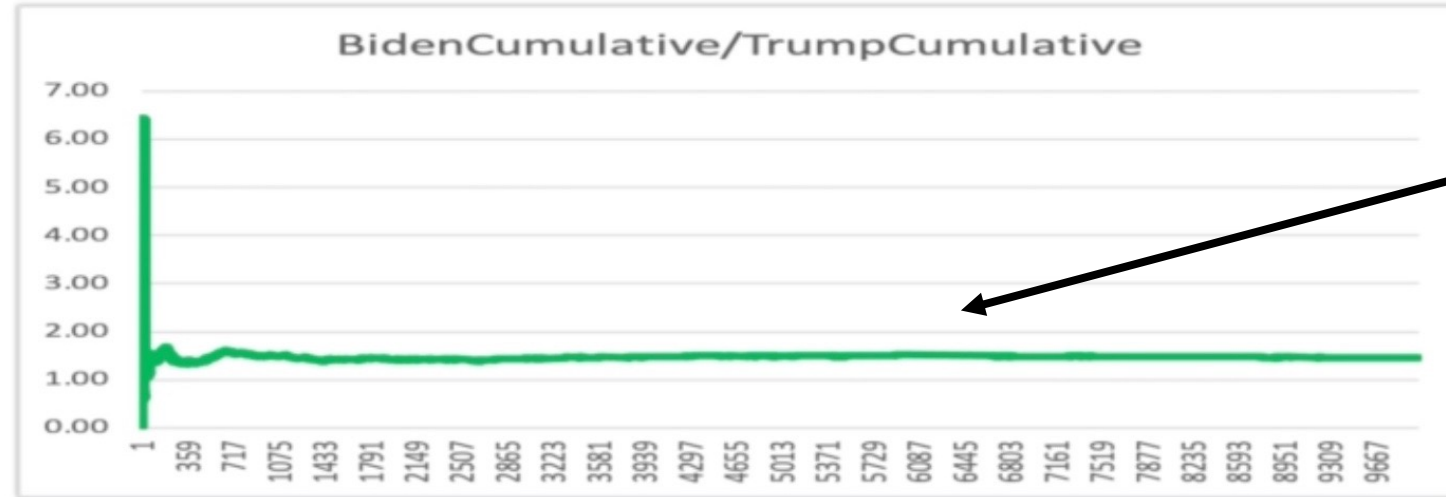

Vote Reporting Ratio of Trump/Biden

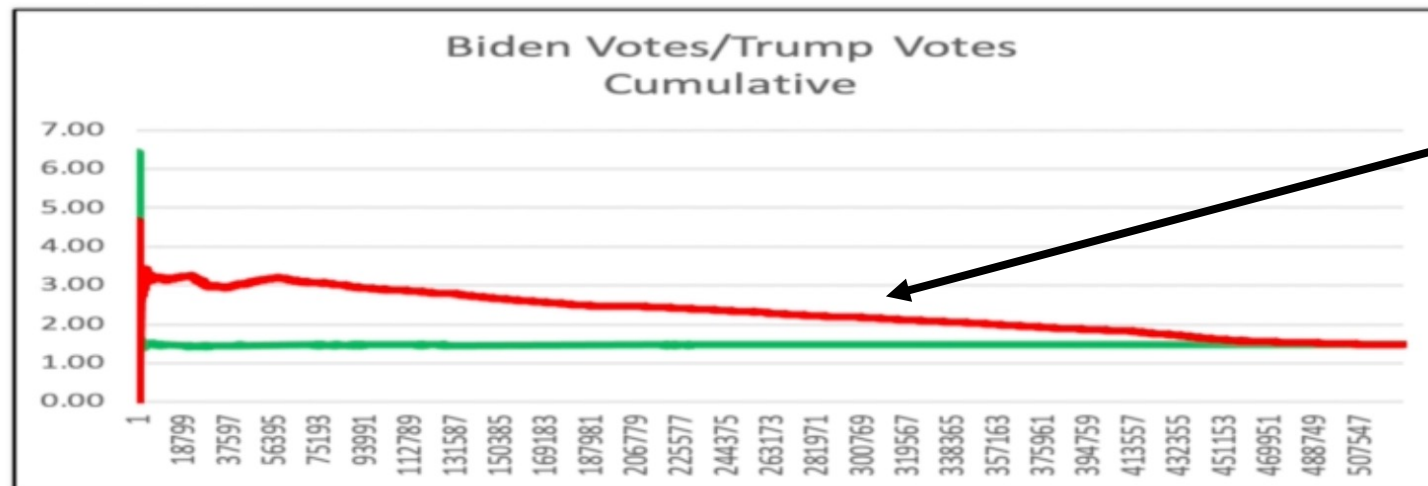

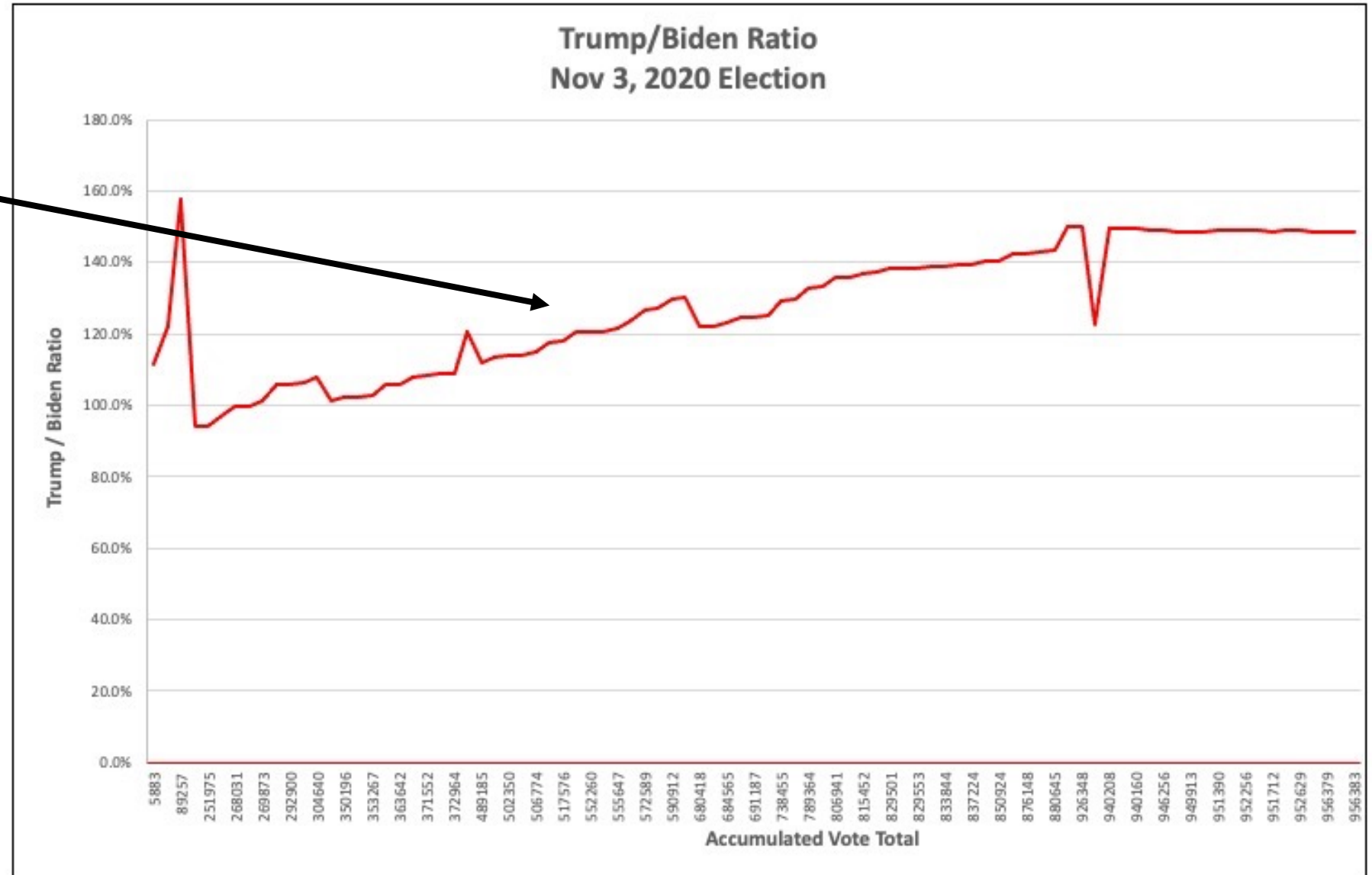

Want Proof? – from Nebraskans!

Prior to the 2020 election we received 3 ballots for Lindsey F. at our address Lindsay is **a daughter** but **has not lived at this address for more than 15 years**. Additionally, **Lindsay's name changed** to Lindsay S. Lindsay was 16 years of age when she last resided at our address and was **NEVER A REGISTERED VOTER WHILE LIVING AT THIS ADDRESS**. When we contacted **Lindsay she said at no time did she request a mail in ballot**. - ✓ *Physical Voting Artifacts such as paper ballots, envelopes, machine hardware/ writers.*
- ✓ *Non-physical Voting Artifacts such as scanned images, envelope images, machine software, network traffic and data and voting, counting and reporting processes.*
- ✓ *Physical Voter Verification through canvassing.*
- ✓ *Non-physical Voter Verification through review of the registration database and signature records.*
